**The Foundation is dedicated to enhancing the lives of youth in the local region through community involvement and collaboration. The Foundation supports youth centered programs through sponsorship and human resources. The major beneficiary of the Foundation is the Morning Star Boys' Ranch (the Ranch) located in Spokane, Washington. The Ranch provides a home environment for boys aged 6-12 who have failed to thrive with their adoptive or foster families providing structure, education, and counseling to assist in building productive citizens. The Foundation distributed approximately \$546,000 to the Ranch during the year and also distributed approximately \$114,000 to other youth programs in the community.**
